WHEREAS, Town of Yorkville Code of Ordinances Section 2-202 provides for the staggered designation and appointment of citizen Plan Commissioners for three-year terms, which shall be subject to confirmation by a majority vote of the Town Board, and

WHEREAS, Town of Yorkville Code of Ordinances Section 54-277 provides for the staggered designation and appointment of Yorkville Stormwater Utility District Commissioners for five year terms, which shall be subject to confirmation of a majority vote of the Town Board, and

- 9. Cheryl Mazmanian, Health Officer, April 30, 2016;
- 10. Scott Chase, Board of Health member, April 30, 2016, and,

BE IT FURTHER RESOLVED, that John Vyvyan be appointed as Yorkville Stormwater Utility District Commissioner for the term expiring April 30, 2018, and

BE IT FURTHER RESOLVED, that the Yorkville Town Board reappoints Town Board Chairperson Peter L. Hansen and Town Board Supervisor Sherry Gruhn to the Plan Commission for one-year terms, expiring on April 30, 2015, and

BE IT FURTHER RESOLVED, that the Yorkville Town Board reappoints Stephen Nelson as Yorkville Stormwater Commission Chairperson for the duration of his term, and

BE IT FURTHER RESOLVED, that no appointments be made to the positions of Emergency Government Director and Zoning Administrator at this time, and

BE IT FURTHER RESOLVED, that no appointments be made to the positions of Weed Commissioner and Plan Commission representative on the Stormwater Commission until such time as suitable candidates are identified, and

BE IT FURTHER RESOLVED, that each of these new appointment terms shall begin on May 1, 2014, and

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption, as required by Wisconsin Statutes 60.80(1), and
