RESOLUTION NO. 03-2013

TOWN OF YORKVILLE RACINE COUNTY, WISCONSIN

A RESOLUTION ADOPTING THE 2014 BUDGETS AND 2013 PROPERTY TAX LEVIES FOR THE TOWN OF YORKVILLE

RECITALS:

WHEREAS, the Yorkville Town Board, per Section 46-121 of the Town of Yorkville Code of Ordinances, is responsible for preparing an annual budget for the efficient and responsible operation of the government, administration and operation of the Town of Yorkville, and

WHEREAS, the Yorkville Town Board recommended a 2014 annual budget to help achieve these goals on October 17, 2013, and

WHEREAS, the Yorkville Sewer Utility, Water Utility and Stormwater Utility Commissions each recommended a 2014 annual budget to help achieve these goals, and

WHEREAS, the Yorkville Town Board, after proper notice had been given in accordance with Wisconsin Statutes 65.90(3)(a)(1), held a public hearing on the proposed 2014 annual budget for these four bodies on November 18, 2013, and

WHEREAS, Electors of the Town of Yorkville, by majority vote at a Special Town Elector Meeting on November 18, 2013, adopted a 2013 Town tax levy to be collected in 2014 in the amount of \$1,105,356.00, and

WHEREAS, Electors of the Town of Yorkville, by majority vote at a Special Town Elector Meeting on November 18, 2013, approved 2014 highway expenditures in the amount of \$696,385.00.

NOW, THEREFORE, BE IT RESOLVED that the Yorkville Town Board hereby adopts the 2014 Town budget in the amount of \$1,400,060.41, and

BE IT FURTHER RESOLVED that the Yorkville Town Board hereby adopts the 2013 tax levy (to be due in 2014) in the amount of \$1,105,356.00 and authorizes and directs the Clerk-Treasurer to distribute the same upon the 2013 tax roll, and

BE IT FURTHER RESOLVED that the Clerk-Treasurer is hereby authorized and directed to distribute upon the 2013 tax roll against respective properties, pursuant to Wisconsin Statutes 66.0809(3), unpaid and delinquent sewer utility charges and penalties of Yorkville Sewer Utility District #1 in the amount of \$1,089.00, and

BE IT FURTHER RESOLVED that the Clerk-Treasurer is hereby authorized and directed to distribute upon the 2013 tax roll against respective properties, pursuant to Wisconsin Statutes 66.0703(13), unpaid and past due sewer line special assessment charges and interest of Yorkville Sewer Utility District #1 in the amount of \$1.980.75, and

BE IT FURTHER RESOLVED that the Clerk-Treasurer is hereby authorized and directed to distribute upon the 2013 tax roll against respective properties stormwater special assessment charges in the amount of \$55,000.00, and

BE IT FURTHER RESOLVED that the Clerk-Treasurer is hereby authorized and directed to distribute upon the 2013 tax roll, in proportion to the 2013 assessed valuations of the Town, the following tax levies:

- 1. Racine County \$1,894,649.63
- 2. Racine County Children with Disabilities \$116,131.95
- 3. State of Wisconsin \$80,216.09
- 4. Union Grove Grade School \$495,730.31
- 5. Yorkville Grade School \$3,230,233.64
- 6. Union Grove High School \$2,208,369.08
- 7. Gateway Technical College \$772,687.14, and

BE IT FURTHER RESOLVED that the 2014 Yorkville Sewer Utility District No. 1 budget of \$356,684.00 be hereby adopted, and

BE IT FURTHER RESOLVED that the 2014 Yorkville Water Utility District No. 1 budget of \$171,843.00 be hereby adopted, and

BE IT FURTHER RESOLVED that the 2014 Yorkville Water Utility District No. 1 tax equivalency charge, created pursuant to Wisconsin Statutes 66.0811(2), remain set at \$17,715.00, and

BE IT FURTHER RESOLVED that the 2014 Yorkville Stormwater Utility District budget of \$201,490.00 be hereby adopted, and

BE IT FURTHER RESOLVED that the 2014 Union Grove-Yorkville Fire Department budget of \$555,787.00 be hereby adopted, with Yorkville's share of the budget being \$188,129.00, and

BE IT FURTHER RESOLVED that this resolution take effect upon adoption, and

BE IT FURTHER RESOLVED that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption as required by Wisconsin Statutes 60.80(1).
