A RESOLUTION UPDATING THE FEE SCHEDULE FOR FEES ESTABLISHED BY YORKVILLE TOWN BOARD POLICY AND VARIOUS PROVISIONS OF THE TOWN OF YORKVILLE CODE OF ORDINANCES

WHEREAS, the Yorkville Town Board enacted Resolution 2008-01 on December 22, 2008, which is an abbreviated and uniform schedule of fees established and charged by the Town of Yorkville through Yorkville Town Board policy and various provisions of the Town of Yorkville Code of Ordinances, and

WHEREAS, the Yorkville Town Board may update this fee schedule by adoption of a resolution, from time to time and as the need arises, if the fees enumerated within are not sufficient to defray the costs for which those fees are collected and intended to cover.

NOW, THEREFORE, BE IT RESOLVED, by the Yorkville Town Board, that the charges for certain services are not sufficient to defray the costs for which those fees are collected and intended to cover, and

BE IT FURTHER RESOLVED, by the Yorkville Town Board, that the Town of Yorkville fee schedule be amended with the following updates:

BE IT FURTHER RESOLVED, that the Clerk-Treasurer is hereby directed to post this resolution in three places within thirty days of its adoption, as required by Wisconsin Statutes 60.80(1), and
